# 7. Contract description:

The aim of this contract is to operate a system of advising farmers on land and farm management and to raise awareness of the probable advisors and farmers on material flows and of on-farm processes relating to the environment, food safety and animal health and welfare, cross-compliance and good agricultural and environmental conditions (GAEC) standards.

The contractor will provide services such as:

— preparation and carrying out of a seminar for EU practices on developing, implementing, monitoring and evaluating of the farm advisory system (FAS), cross compliance rules, GAEC standards,

- review of the Turkish legislation and practice related to advisory services,

— analysis of the future tasks and responsibilities of the General Directorate of Agricultural Reform (GDAR) — integrated administration and control system (IACS) department,

- study visit of Turkish experts to accurately present the FAS and its framework and regulations,

— drafting of proposal for procedures, rules and programmes for establishing and operation of the future FAS coordination centre,

- promotion of FAS, preparation of application forms to farmers,

#### **Conditions of participation**

## 11. Eligibility:

Participation is open to all natural persons who are nationals of, and legal persons (participating either individually or in a grouping — consortium — of tenderers) which are effectively established in, a Member State of the European Union or in an eligible country or territory as defined under the Regulation (EU) No 236/2014 of the European Parliament and of the Council of 11.3.2014 laying down common rules and procedures for the implementation of the Union's instruments for financing external action (CIR) for the applicable instrument under which the contract is financed (see also heading 29 below). Participation is also open to international organisations.

## 12. Candidature:

All eligible natural and legal persons (as per item 11 above) or groupings of such persons (consortia) may apply.

A consortium may be a permanent, legally-established grouping or a grouping which has been constituted informally for a specific tender procedure. All members of a consortium (i.e., the leader and all other members) are jointly and severally liable to the contracting authority.

The participation of an ineligible natural or legal person (as per item 11) will result in the automatic exclusion of that person. In particular, if that ineligible person belongs to a consortium, the whole consortium will be excluded.

#### 13. Number of applications:

No more than 1 application can be submitted by a natural or legal person whatever the form of participation (as an individual legal entity or as a leader or member of a consortium submitting an application). In the event that a natural or legal person submits more than 1 application, all applications in which that person has participated will be excluded.

#### 14. Shortlist alliances prohibited:

Any tenders received from tenderers comprising firms other than those mentioned in the shortlisted application forms will be excluded from this restricted tender procedure unless prior approval from the contracting authority has been obtained (see 'Practical Guide' — PRAG 2.4.3). Shortlisted candidates may not form alliances or subcontract to each other for the contract in question.

#### 15. Grounds for exclusion:

As part of the application form, candidates must submit a signed declaration, included in the standard application form, to the effect that they are not in any of the exclusion situations listed in Section 2.3.3 of the PRAG.

#### 16. Subcontracting:

#### Selection and award criteria 21. Selection criteria:

The following selection criteria will be applied to candidates. In the case of applications submitted by a consortium, these selection criteria will be applied to the consortium as a whole unless specified otherwise. The selection criteria will not be applied to natural persons and single-member companies when they are subcontractors.

1) Economic and financial capacity of candidate (based on item 3 of the application form). In the case of the candidate being a public body, equivalent information should be provided. The reference period which will be taken into account will be the last 3 years for which accounts have been closed:

Criteria for legal and natural persons:

1. the average annual turnover of the candidate must exceed 1 500 000 EUR.

2) Professional capacity of candidate (based on items 4 and 5 of the application form). The reference period which will be taken into account will be the last 3 years from the submission deadline: Criteria for legal and natural persons:

1. at least 5 staff currently working for the candidate in fields related to this contract are permanent.

3) Technical capacity of candidate (based on items 5 and 6 of the application form). The reference period which will be taken into account will be the last 5 years from the submission deadline:

Criteria for legal and natural persons:

1. the candidate has provided services under at least 1 contract with a budget of at least 1 500 000 EUR (proportion carried out by the candidate) on delivering technical assistance in the field of agriculture which was implemented at any moment during the reference period: 5 years from the submission deadline (the start and end/completion dates of the references should be specified as day/month/year);

2. the candidate has provided services under at least 1 contract with a budget of at least 500 000 EUR (proportion carried out by the candidate) in the field of farm advisory services which was implemented at any moment during the reference period: 5 years from the submission deadline (the start and end/completion dates of the references should be specified as day/month/year);

3. the candidate has provided services under at least 1 contract with a budget of at least 500 000 EUR (proportion carried out by the candidate) in the field of cross-compliance which was implemented at any moment during the reference period: 5 years from the submission deadline (the start and end/completion dates of the references should be specified as day/month/year).

This means that the contract the candidate refers to could have been started or completed at any time during the indicated period but it does not necessarily have to be started and completed during that period, nor implemented during the entire period. Candidates/tenderers are allowed to refer either to projects completed within the reference period (although started earlier) or to projects not yet completed. In the first case the project will be considered in its whole if proper evidence of performance is provided (statement or certificate from the entity which awarded the contract, proof of final payment). In the case of projects still ongoing only the portion satisfactorily completed during the reference period although started earlier will be taken into consideration. This portion will have to be supported by documentary evidence (similarly to projects completed) also detailing its value.

If a candidate/tenderer has implemented the project in a consortium, the percentage that the candidate/tenderer has successfully completed must be clear from the documentary evidence, together with a description of the nature of the services provided.

Previous experience which caused breach of contract and termination by a contracting authority shall not be used as reference.

An economic operator may, where appropriate and for a particular contract, rely on the capacities of other entities, regardless of the legal nature of the links which it has with them. It must in that case prove to the contracting authority that it will have at its disposal the resources necessary for performance of the contract, for example by producing a commitment on the part of those entities to place those resources at its disposal. Such entities, for instance the parent company of the economic operator, must respect the same rules of eligibility — notably that of nationality — and must fulfil the same relevant selection criteria as the economic operator. With regard to technical and professional criteria, an economic operator may only rely on the capacities of other entities where the latter will perform the works or services for which these capacities are required. With regard to economic and financial criteria, the entities upon whose capacity the tenderer relies, become jointly and severally liable for the performance of the contract.

If more than 8 eligible candidates meet the above selection criteria, the relative strengths and weaknesses of the applications of these candidates must be re-examined to identify the 8 best candidates. The only factors which will be taken into consideration during this re-examination are:

• the total number of occurrences of references satisfying technical capacity criterion 21.3.2 above, and

• for cases with equal standing, the total amount of the references (proportion carried out by candidate) satisfying technical capacity criterion 21.3.2.
