## 3. **Programme title:**

National programme for Turkey 2013 under the Instrument for Pre-Accession Assistance — transition assistance and institution building component.

#### 4. Financing:

#### 6. **Nature of contract:**

Global price.

#### 7. Contract description:

The main purpose of the project is to provide technical assistance to Turkish National Police (TNP) road safety services which contributes to the improvement of road safety conditions in Turkey in line with the EU policies and global strategies in order to diminish casualties and losses in road crashes. The contractor is expected to provide the following services:

- i) in-depth analysis of present conditions, legal and institutional framework and carrying out a mid-term evaluation of the road safety action plan (2011–2020) and to prepare a strategy document related with the road safety for the period 2021–2030;
- ii) improving institutional capacity of Turkish National Police (TNP) road safety services via preparation of relevant road map, guidelines and manuals, draft project proposals for tackling road safety issues as well as organisation of study visits to observe best practices;
- iii) improving the production and dissemination process of road crash statistics in terms of definition of statistics as well as data registry and sharing;
- iv) contributing to the capacity improvement of TNP road safety services regarding the public relations, communication and advocacy strategies supported by the activities such as public informative events, dissemination of promotional and informative materials or using audiovisual tools.

## **Conditions of participation**

# 11. Eligibility:

Participation is open to all legal persons (participating either individually or in a grouping — consortium — of tenderers) which are established in a Member State of the European Union or in a country or territory of the regions covered and/or authorised by the specific instruments applicable to the programme under which the contract is financed (see item 29 below). Participation is also open to international organisations. Participation of natural persons is directly governed by the specific instruments applicable to the programme under which the contract is financed.

#### 12. Candidature:

All eligible natural and legal persons (as per item 11 above) or groupings of such persons (consortia) may apply.

A consortium may be a permanent, legally-established grouping or a grouping which has been constituted informally for a specific tender procedure. All members of a consortium (i.e., the leader and all other members) are jointly and severally liable to the contracting authority.

The participation of an ineligible natural or legal person (as per item 11) will result in the automatic exclusion of that person. In particular, if that ineligible person belongs to a consortium, the whole consortium will be excluded.

# 13. Number of applications:

No more than 1 application can be submitted by a natural or legal person whatever the form of participation (as an individual legal entity or as a leader or member of a consortium submitting an application). In the event that a natural or legal person submits more than 1 application, all applications in which that person has participated will be excluded.

# 14. Shortlist alliances prohibited:

Any tenders received from tenderers comprising firms other than those mentioned in the shortlisted application forms will be excluded from this restricted tender procedure unless prior approval from the contracting authority has been obtained (see 'Practical Guide' — PRAG 2.4.3). Shortlisted candidates may not form alliances or subcontract to each other for the contract in question.

#### 15. Grounds for exclusion:

As part of the application form, candidates must submit a signed declaration, included in the standard application form, to the effect that they are not in any of the exclusion situations listed in Section 2.3.3 of the PRAG.

## 16. **Subcontracting:**

Subcontracting is allowed.

# 17. Number of candidates to be shortlisted:

On the basis of the applications received, between 4 and 8 candidates will be invited to submit detailed tenders for this contract. If the number of eligible candidates meeting the selection criteria is less than the minimum of 4, the contracting authority may invite the candidates who satisfy the criteria to submit a tender.

#### Selection and award criteria

# 21. Selection criteria:

The following selection criteria will be applied to candidates. In the case of applications submitted by a consortium, these selection criteria will be applied to the consortium as a whole unless specified otherwise. The selection criteria will not be applied to natural persons and single-member companies when they are subcontractors:

1) Economic and financial capacity of candidate (based on item 3 of the application form). In the case of the candidate being a public body, equivalent information should be provided. The reference period which will be taken into account will be the last 3 years for which accounts have been closed:

Criteria for legal and natural persons:

- 1. the average annual turnover of the candidate must exceed 1 400 000 EUR.
- 2) Professional capacity of candidate (based on items 4 and 5 of the application form). The reference period which will be taken into account will be the last 3 years from the submission deadline: Criteria for legal and natural persons:
- 1. at least 5 staff currently work for the candidate in fields related to this contract.
- 3) Technical capacity of candidate (based on items 5 and 6 of the application form). The reference period which will be taken into account will be the last 5 years from the submission deadline:

  Criteria for legal and natural persons:
- 1. the candidate has provided services under a single contract with a minimum value of 1 500 000 EUR (proportion carried out by the candidate) in the field of institutional capacity building on transportation, which was implemented at any moment during the following period: 5 years prior to the submission deadline of this application (the start and end/completion dates of the references should be specified as day/month/year information);
- 2. the candidate has provided services under a single contract, with a minimum value of 500 000 EUR (proportion carried out by the candidate) related with road safety services, which was implemented at any moment during the following period: 5 years prior to the submission deadline of this application (the start and end/completion dates of the references should be specified as day/month/year information).

This means that the contract the candidate refers to could have been started or completed at any time during the indicated period but it does not necessarily have to be started and completed during that period, nor implemented during the entire period. Candidates/tenderers are allowed to refer either to contracts completed within the reference period (although started earlier) or to contracts not yet completed. In the first case the contract will be considered in its whole if proper evidence of performance is provided (statement or certificate from the entity which awarded the contract, proof of final payment). In the case of contracts still ongoing only the portion satisfactorily completed during the reference period although started earlier will be taken into consideration. This portion will have to be supported by documentary evidence (similarly to contracts completed) also detailing its value. If a candidate/tenderer has implemented the contract in a consortium, the percentage that the candidate/tenderer has successfully completed must be clear from the documentary evidence, together with a description of the nature of the services provided.

Previous experience which caused breach of contract and termination by a contracting authority shall not be used as reference.

An economic operator may, where appropriate and for a particular contract, rely on the capacities of other entities, regardless of the legal nature of the links which it has with them. It must in that case prove to the contracting authority that it will have at its disposal the resources necessary for performance of the contract, for

example by producing a commitment on the part of those entities to place those resources at its disposal. Such entities, for instance the parent company of the economic operator, must respect the same rules of eligibility — notably that of nationality — and must fulfil the same relevant selection criteria as the economic operator. With regard to technical and professional criteria, an economic operator may only rely on the capacities of other entities where the latter will perform the works or services for which these capacities are required. With regard to economic and financial criteria, the entities upon whose capacity the tenderer relies become jointly and severally liable for the performance of the contract.

If more than 8 eligible candidates meet the above selection criteria, the relative strengths and weaknesses of the applications of these candidates must be re-examined to identify the 8 best candidates. The only factors which will be taken into consideration during this re-examination are:

- 1) the total number of the references fulfilling the technical capacity criterion 21.3)2; and
- 2) for the cases of equality in line with the first re-examination criterion, the second re-examination criterion will be the total amount of the references (proportion carried out by the candidate) satisfying the technical capacity criterion 21.3)2 above.
