Central Finance and Contracts Unit (CFCU), Ankara, TURKEY.

**Contract specifications**

6. **Description of the contract**  
This contract aims at arraying 3 multipurpose community centres as public facilities in Van province which will accommodate community support services, programs and activities and target internally displaced persons (IDPs) and other socially vulnerable groups. In this sense, the contract includes the supply, delivery, installation, commissioning, testing, inspection, training (except for Lot 1 and Lot 5) and warranty services (please refer to Article 32.6 of Special Conditions for the exceptions) of the relevant equipment of these community centres.
7. **Number and titles of lots**  
7 lots:  
Lot 1: Furniture  
Lot 2: Electrical Appliances  
Lot 3: IT Appliances  
Lot 4: Sports, Handcraft and Kitchen Equipment  
Lot 5: Kindergarten Equipment  
Lot 6: Vehicle  
Lot 7: Security Equipment

**Terms of participation**

8. **Eligibility and rules of origin**  
Participation is open to all natural persons who are nationals of and legal persons (participating either individually or in a grouping – consortium - of tenderers) which are effectively established in a Member State of the European Union or in a eligible country or territory as defined under the Regulation (EU) N<sup>o</sup> 236/2014 establishing common rules and procedures for the implementation of the Union's instruments for external action (CIR) for the applicable Instrument under which the contract is financed (see also heading 22 below). Participation is also open to international organisations.

All supplies under this contract (except for Lot 2, Lot 4 and Lot 5) must originate in one or more of these countries. The supplies under Lot 2, Lot 4 and Lot 5 may originate from any country.

Please be aware that after the United Kingdom's withdrawal from the EU, the rules of access to EU procurement procedures of economic operators established in third countries and of goods originating from third countries will apply to candidates or tenderers from the United Kingdom, and to all candidates or tenderers proposing goods originating from the United Kingdom depending on the outcome of negotiations. In case such access is not provided by legal provisions in force at the time of the contract award, candidates or tenderers from the United Kingdom, and candidates or tenderers proposing goods originating from the United Kingdom could be rejected from the procurement procedure.

9. **Grounds for exclusion**

Tenderers must submit a signed declaration, included in the Tender Form for a Supply Contract, to the effect that they are not in any of the situations listed in point 2.3.3 of the Practical Guide.

10. **Number of tenders**

Tenderers may submit only 1 tender per lot. Tenders for parts of a lot will not be considered. Any tenderer may state in its tender that it would offer a discount in the event that its tender is accepted for more than one lot. Tenderers may not submit a tender for a variant solution in addition to their tender for the supplies required in the tender dossier.

11. **Tender guarantee**

Tenderers must provide a tender guarantee of:

For lot 1: 3.200,00 EUR

For lot 2: 1.500,00 EUR

For lot 3: 3.500,00 EUR

For lot 4: 1.100,00 EUR

For lot 5: 1.000,00 EUR

For lot 6: 5.400,00 EUR

For lot 7: 1.900,00 EUR

When submitting their tender. This guarantee will be released to unsuccessful tenderers once the tender procedure has been completed and to the successful tenderer[s] upon signature of the contract by all parties. This guarantee will be called upon if the tenderer does not fulfil all obligations stated in its tender.

If the tenderer is bidding for more than 1 lot, it has to provide either a tender guarantee with a total amount of the relative lots he is bidding for or separate tender guarantees for each lot.

12. **Performance guarantee**

The successful tenderer will be asked to provide a performance guarantee of 10 % of the amount of the contract at the signing of the contract. This guarantee must be provided together with the return of the countersigned contract no later than 30 days after the tenderer receives the contract signed by the Contracting Authority. If the selected tenderer fails to provide such a guarantee within this period, the contract will be void and a new contract may be drawn up and sent to the tenderer which has submitted the next cheapest compliant tender.

13. **Information meeting and/or site visit**

No information meeting is planned.

14. **Tender validity**

Tenders must remain valid for a period of 90 days after the deadline for submission of tenders. In exceptional circumstances, the Contracting Authority may, before the validity period expires, request that tenderers extend the validity of tenders for a specific period (see para 8.2 of the instructions to tenderers).

15. **Period of implementation of tasks**

The period of implementation of the tasks is 1080 calendar days for all lots from the commencement date of the contract.

### **Selection and award criteria**

#### **16. Selection criteria**

The following selection criteria will be applied to tenderers. In the case of tenders submitted by a consortium, these selection criteria will be applied to the consortium as a whole unless specified otherwise. The selection criteria will not be applied to natural persons and single-member companies when they are sub-contractors:

1) Economic and financial capacity of tenderer (based on i.a. item 3 of the Tender Form for a Supply Contract).

In the case of the tenderer being a public body, equivalent information should be provided. The reference period which will be taken into account will be the last 3 years for which accounts have been closed:

— Lot 1: the average annual turnover of the tenderer must exceed 160 000,00 EUR,

— Lot 2: the average annual turnover of the tenderer must exceed 70 000,00 EUR,

— Lot 3: the average annual turnover of the tenderer must exceed 175 000,00 EUR,

— Lot 4: the average annual turnover of the tenderer must exceed 55 000,00 EUR,

— Lot 5: the average annual turnover of the tenderer must exceed 45 000,00 EUR,

— Lot 6: the average annual turnover of the tenderer must exceed 270 000,00 EUR,

— Lot 7: the average annual turnover of the tenderer must exceed 95 000,00 EUR.

2) Professional capacity of tenderer (based on i.a. items 4 and 5 of the tender form for a supply contract). The reference period which will be taken into account will be the last 3 years from submission deadline:

— at least 5 staff must currently work for the tenderer.

3) Technical capacity of tenderer (based on i.a. items 5 and 6 of the tender form for a supply contract): The reference period which will be taken into account will be the last 5 years from submission deadline.

Lot 1:

— the tenderer has delivered supplies under at least 1 contract with a budget of at least 110 000,00 EUR (proportion carried out by the candidate) in the field of furniture, which was implemented during the following period: 5 years from the submission deadline (the start and end/completion dates of the references should be specified as day / month / year).

Lot 2:

— the tenderer has delivered supplies under at least 1 contract with a budget of at least 50 000,00 EUR (proportion carried out by the candidate) in the field of electrical appliances, which was implemented during the following period: 5 years from the submission deadline (the start and end/completion dates of the references should be specified as day / month / year).

Lot 3:

— the tenderer has delivered supplies under at least 1 contract with a budget of at least 120 000,00 EUR (proportion carried out by the candidate) in the field of IT appliances, which was implemented during the following period: 5 years from the submission deadline (the start and end/completion dates of the references should be specified as day/month/year).

Lot 4:

— the tenderer has delivered supplies under at least 2 contracts with a cumulative budget of at least 40 000,00 EUR (proportion carried out by the candidate) in the field of sports, handcraft or kitchen equipment, which were implemented during the following period: 5 years from the submission deadline (the start and end/completion dates of the references should be specified as day/month/year).

Lot 5:

— the tenderer has delivered supplies under at least 1 contract with a budget of at least 30 000,00 EUR (proportion carried out by the candidate) in the field of kindergarten equipment, which was implemented during

the following period: 5 years from the submission deadline (the start and end/completion dates of the references should be specified as day / month / year).

Lot 6:

— the tenderer has delivered supplies under at least 1 contract with a budget of at least 180 000,00 EUR (proportion carried out by the candidate) in the field of vehicle, which was implemented during the following period: 5 years from the submission deadline (the start and end/completion dates of the references should be specified as day / month / year).

Lot 7:

— the tenderer has delivered supplies under at least 1 contract with a budget of at least 65 000,00 EUR (proportion carried out by the candidate) in the field of security equipment, which was implemented during the following period: 5 years from the submission deadline (the start and end/completion dates of the references should be specified as day / month / year).

In case a tenderer applies to multiple lots, the tenderer should meet;

— for economic and financial capacity criterion, the cumulative amount of the average annual turnover required for the relative lots,

— for professional capacity criterion, cumulative number of staff required for the relative lots.

If the tenderer does not meet the required selection criteria for all the lots he applied, his tender will only be taken into consideration for the lot(s) he is qualified for. In this case, the Contracting Authority will choose the most favorable overall solution taking into account the financial offers and the discounts granted. In this respect, the tenderers have no preferences on the lots.

This means that the contract the tenderer refers to could have been started or completed at any time during the indicated period but it does not necessarily have to be started and completed during that period, nor implemented during the entire period. Tenderers are allowed to refer either to projects completed within the reference period (although started earlier) or to projects not yet completed. In the first case the project will be considered in its whole if proper evidence of performance is provided (statement or certificate from the entity which awarded the contract, final acceptance). In case of projects still on-going only the portion satisfactorily completed during the reference period will be taken into consideration. This portion will have to be supported by documentary evidence (similarly to projects completed) also detailing its value.

Capacity-providing entities

An economic operator may, where appropriate and for a particular contract, rely on the capacities of other entities, regardless of the legal nature of the links which it has with them. Some examples of when it may not be considered appropriate by the Contracting Authority are when the tenderer relies in majority on the capacities of other entities or when they rely on key criteria. If the tenderer relies on other entities it must prove to the Contracting Authority that it will have at its disposal the resources necessary for performance of the contract, for example by producing a commitment on the part of those entities to place those resources at its disposal. Such entities, for instance the parent company of the economic operator, must respect the same rules of eligibility and notably that of nationality, as the economic operator. Furthermore, the data for this third entity for the relevant selection criterion should be included in the tender in a separate document. Proof of the capacity will also have to be furnished when requested by the Contracting Authority.

With regard to technical and professional criteria, a tenderer may only rely on the capacities of other entities where the latter will perform the tasks for which these capacities are required.

With regard to economic and financial criteria, the entities upon whose capacity the tenderer relies, become jointly and severally liable for the performance of the contract.
